ELIGIBILITY CRITERIA

1. Membership:

- a. All the persons heading a technology business based in Goa, above the age of 18 years having a good character, irrespective of caste, creed and sex shall be eligible for the membership of the Association.
- b. The proposal for admission of such member shall be put forth in the next Managing Committee meeting which needs to be passed by majority for a person, failing which the admission fee & membership fee so collected is to be refunded in full.
- c. The Membership of the Association shall be renewed on the annual basis; on payment of membership fees as mention in point number (4). The annual membership fees will come due at the beginning of every financial year.
- d. The Managing Committee shall have the power to increase, decrease or vary the amount of annual subscription from time to time. Additional subscription, in addition to the annual subscription referred to hereinabove, may be collected by the Governing Body from Members for a general or specific purpose or project.

2. Members, Admission Fee & Subscription:

(A) Primary Members:

Any Technology Businessman can become a Primary Member of the GTA. He will be able to contest and vote in the elections of GTA as per the rules of the GTA. Primary member shall have to pay the registration fees (one time) and annual subscription fees of GTA as shall be decided by the Managing Committee from time to time.

Fees:

- i. One time registration fee – Rs.3,000/- (Rupees Three Thousand) only
- ii. Annual Fees of Primary Members Rs. 3,000/- (Rupees Three Thousand) only

(B) Corporate Members:

A Corporate Member can nominate two representatives. Either one can vote in the election of the GTA. Only one can contest as a candidate in the elections. Corporate member shall have to pay the registration fees (one time) and annual subscription fees of GTA as shall be decided by the Managing Committee from time to time.

Fees:

- i. One time registration fee – Rs.3,000/- (Rupees Three Thousand) only
- ii. Annual Fees of Corporate Members Rs. 7,000/- (Rupees Seven Thousand) only

(C) Associate Members:

- Educational Institutes – Annual Fees – Rs.5,000/-
- Other Associations – Annual Fees - Rs.10,000/-

(D) Managing Committee:

- Should be a Primary Member.
- Should not be a President / Chairman of other Business Association.
- Nominated / Elected by Primary Member
- Only two corporate members can be elected to the Managing Committee.

(E) Advisory Committee:

- Corporate Heads (CXO's)
- President / Chairman of other Business Association
- Venture Capitalists
- Should be nominated by Managing Committee

The admission fee and the subscription shall be as above unless otherwise revised by the Managing Committee of the GTA.

3. Rights of the Member:

- a. To participate actively all the General Meetings of the Association and vote and elect the Managing Committee.
- b. To contest elections and get elected as the Office Bearer to the Managing Committee.
- c. To actively participate in all the activities of the Association.
- d. To represent the Association at various forums with prior permission of Managing Committee.
- e. To bring any matter in front of the Managing Committee for the betterment of the Association.
- f. To examine and appreciate the books of the Accounts of the Association.
- g. To call for a meeting of the General Body, provided the petition is signed by at least 2/3rd members and addressed to the President of Managing Committee.

4. Duties of the Members:

- a. To follow the objectives of the Association in a healthy manner.
- b. To work for the growth of the Association.
- c. To preach and propagate the ideology of the Association
- d. To pay the membership fees regularly.
- e. Not indulge in activities which are prejudicial to the aims and objects and/or the Rules.
- f. In the event of any changes in his address, telephone number and other details, promptly notify the new address, telephone number or other details to the Secretary, who shall thereupon enter the same in the Register of Members.

5. The members shall not have the right to ask for refunding the money contributed in any case whatsoever.
